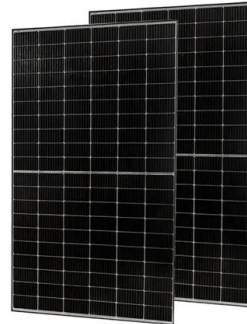


Alcazar Energy closes US\$490M for renewable energy fund

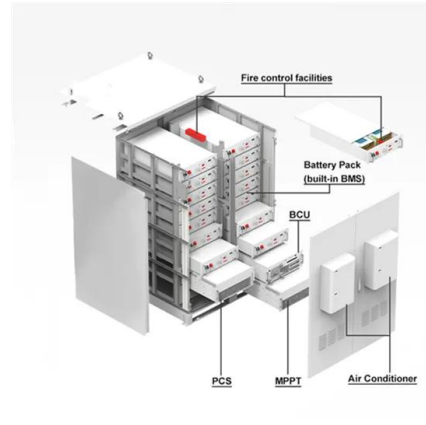

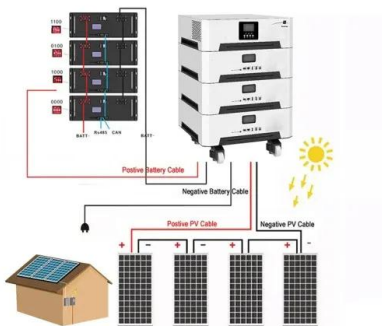
