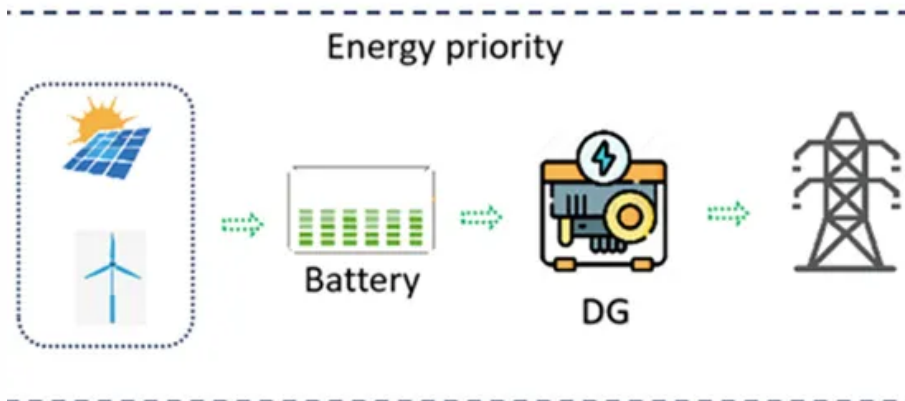

Allied Technologies Limited (Altech) is listed on the Johannesburg Stock Exchange (JSE). The group focuses on convergence in Telecommunications, Multi-media and Information Technology (TMT) industries locally and abroad.

Does Altech have a stake in liquid?

Altech will contribute its majority interests in Altech East Africa on a net debt-free and cash-free basis, as well as subscribe and pay US\$16.5m for new shares in Liquid, to give it an initial 8.6% equity stake in the company, with shareholder voting rights of 10%, and the potential to further increase the shareholding in Liquid in the future.
