Beijing may ban the export of technology used to make solar panels, an industry which China dominates by controlling at least 75% of its global supply chain. That has repercussions for the West.

Pursuant to the Presidential Proclamation issued on June 6, 2022, duties will not be collected on any solar module and cell imports from these four countries until June 2024, as long as the imports are consumed in the U.S. market within six months of the termination of the President's Proclamation.

After a more than year-long investigation, federal officials have concluded that five Chinese solar panel companies have been skirting US tariff laws by routing their operations through four.

According to the United States government, certain Chinese producers have been circumventing US import duties by exporting solar energy equipment from Southeast Asian countries to the US. New steep import tariffs are scheduled to be imposed on these companies in June 2024.Why is China considering new export restrictions on solar manufacturing technologies?

China is considering new export restrictions on solar manufacturing technologies to boost its global dominance in the solar industry.

Can solar panels be exported outside China?

The ban will not restrict the supply of complete wafers for solar panels, but it

will restrict the technology exports needed to produce them outside of China. If the three proposed solar technologies are added to the restrictions list, manufacturers will need to obtain provincial licenses in order to export such products.

Will a retroactive tax on solar panels hurt the solar industry?

Retroactive taxes on solar panels from China are likely to dramatically increase costs for U.S. solar installers. If the government decides to impose these taxes on the country's primary sources of solar panels, the resulting stress on the supply chain could put a damper on the solar industry's expansion.

How many dumping and import taxes are imposed on solar PV?

Since 2011, the number of antidumping, countervailing and import duties levied against parts of the solar PV supply chain has increased from just 1 import tax to 16 duties and import taxes, with 8 additional policies under consideration. Altogether, these measures cover 15% of global demand outside of China.

When will solar module imports be taxable?

Pursuant to the Presidential Proclamation issued on June 6, 2022, duties will not be collected on any solar module and cell imports from these four countries until June 2024, as long as the imports are consumed in the U.S. market within six months of the termination of the President's Proclamation.

What are China's new export controls for solar panels?

The proposed rules will put advanced technologies used to make ingots and wafers, key parts that make up solar panels, on a list of export controls, according to a public consultation process jointly published in December by China's Ministry of Commerce and Ministry of Science and Technology.
