Does the BVI have solar energy resources?

Based on renewable energy resources for proximate island nations, the BVI is estimated to have developable solar and wind resources, although no specific values have been published. In September 2014, BVIEC held a solicitation for companies to develop roughly 2 MW of solar photovoltaic Electricity Sector Overview.

Does Cooper Island use solar energy?

Cooper Island generates more than 75% of its electric needs from solar PV and uses solar water heating. Virgin Limited Edition has proposed building a resort on Moskito Island with enough renewable energy generation to make the site carbon-neutral.

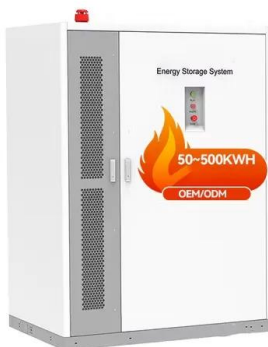
