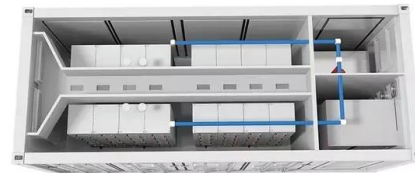


The Batteries Regulation: state of play and what to consider during

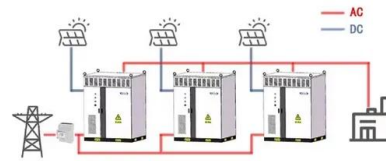

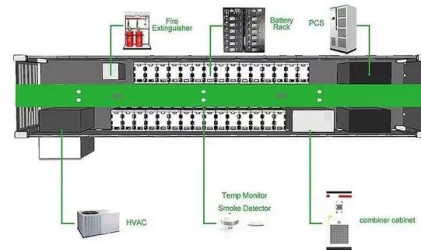
