Disputes among photovoltaic inverter manufacturers



Overview

Are SolarEdge & AMPT litigating a patent dispute?

SolarEdge and AMPT have been litigating a patent dispute involving a patent family filed by SolarEdge and a patent family filed by AMPT before the United States Patent and Trademark Office (USPTO) for many years.

Are solar technology patents being litigated?

Given the relatively mature state of solar technology and the number of companies operating and seeking to operate in the sector, it is not surprising that there has been an increase in litigation in recent years concerning the patents underlying solar technologies. One of the most significant disputes to date has been between SolarEdge and Huawei.

Is SolarEdge patent infringement?

Image: Ampt. Power optimiser provider Ampt has filed two lawsuits against SolarEdge in the US alleging patent infringement on power optimiser technology. Ampt has filed a complaint with the US International Trade Commission (ITC) against SolarEdge requesting a ban on imports of SolarEdge's power systems and components that infringe Ampt's patents.

Does SolarEdge have a patent dispute with SMA Solar?

SolarEdge is also involved in a global patent dispute with competitor SMA Solar Technology, in which SolarEdge is defending infringement proceedings and challenging the validity of SMA Solar's patents that also relate to inverter technology. Another separate, ongoing multi-jurisdictional dispute of note is between Hanwha Q-Cells and Longi Solar.

Are SolarEdge and Huawei infringing patents?

One of the most significant disputes to date has been between SolarEdge and Huawei. In 2018, SolarEdge commenced infringement proceedings in Germany before the Mannheim Regional Court for infringing three of its

European patents concerning inverter technology for photovoltaic systems and for use in solar panels.

Why did SolarEdge file a lawsuit against Huawei?

SolarEdge also filed three lawsuits against Huawei in the regional courts of Jinan and Shenzhen. In Germany, Huawei had lodged a lawsuit against Israel-based SolarEdge in relation to multi-level inverter topology, which led to the revocation of the validity of SolarEdge's patent.
