The two tax exemptions — property and sales — are applicable to individuals and companies that install solar energy panels onto a property.

To make a claim, you need to file an IRS Form 5695 in addition to your tax return. You'll then calculate the credit on Part I of the form and submit the final result in your 1040.

Are solar panels tax deductible?

This tax exemption allows homeowners and businesses to exclude the total cost of a solar project (including installation) for tax benefits. This exemption allows taxpayers to install solar panels on either commercial or residential property. At the time of writing this article, 36 U.S. states provide property tax exemptions for solar panels.

How many states have a solar property tax exemption policy?

In total, 25 states have an active solar property tax exemption policy. Of those 25 states, 21 have policies that give tax exemptions to residential solar projects, like a small rooftop or ground mount solar array. The other four states only offer solar property tax exemptions to non-residential solar projects.

What are solar property tax exemptions?

Solar property tax exemptions give homeowners the right to remove the added value of a solar panel system from the valuation of their home for tax purposes.

Are solar panels eligible for the federal solar tax credit?

Free, No-commitment Estimates To be eligible for the federal solar tax credit, you need to install a solar-powered energy system that provides electricity to a U.S. residence. Solar panels, solar water heaters and energy storage devices are all included in the credit.

Do solar panels affect property taxes?

When you install solar panels on your property, it can potentially affect your property taxes. However, the extent of the impact depends on the state you live in and its tax laws. In some states, such as California and New Jersey, installing solar panels can actually increase your property value and therefore increase your property taxes.

Are solar PV systems eligible for a tax credit?

Solar PV systems installed in 2020 and 2021 are eligible for a 26% tax credit. In August 2022, Congress passed an extension of the ITC, raising it to 30% for the installation of which was between 2022-2032. (Systems installed on or before December 31, 2019 were also eligible for a 30% tax credit.)
