The total installed capacity of our power plants is 859 MW, while the annual power generation is more than 2.5 TWh. One part of the multinational group ENERGO-PRO headquartered in Prague, is the Slovenian manufacturer of

water turbines, Litostroj Power, with significant projects in Canada and USA.

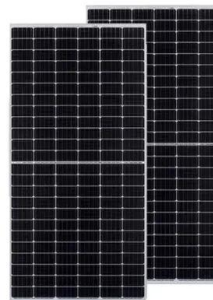

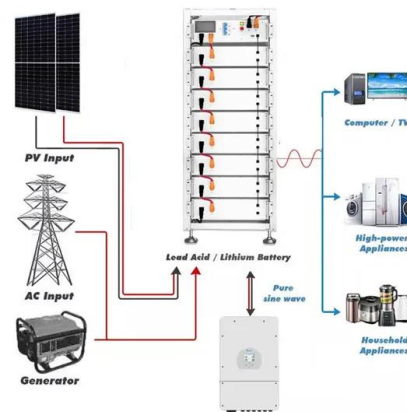
