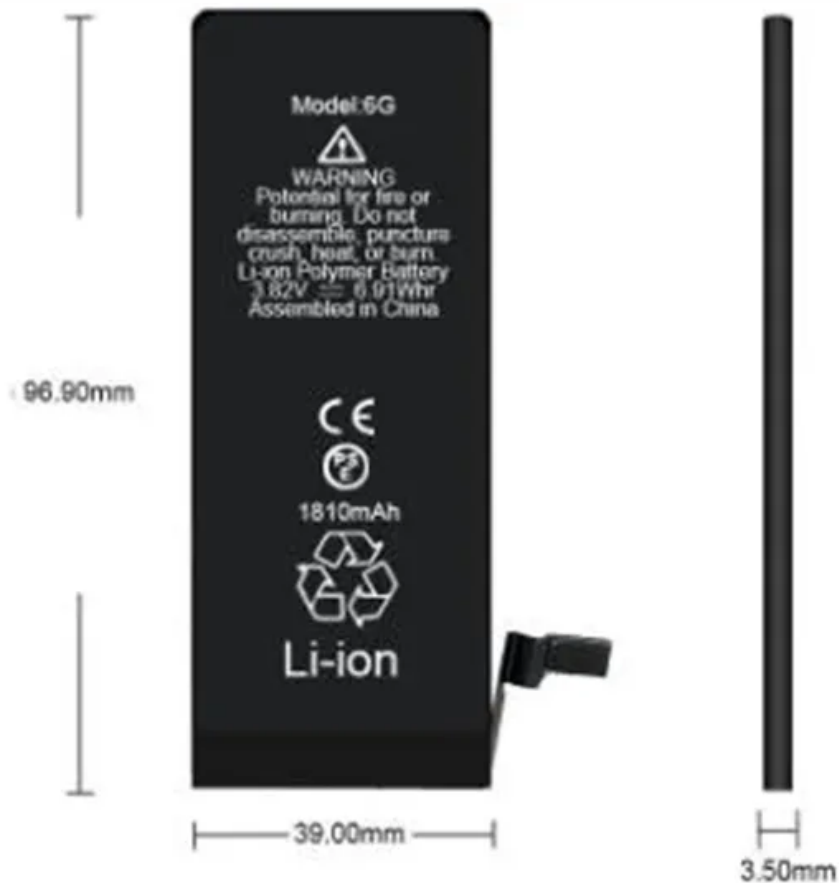

The new funds will allow EsVolta to secure obligations relating to interconnection, power purchase agreements (PPAs), equipment deposits as well as early pre-NTP (notice-to-proceed).
