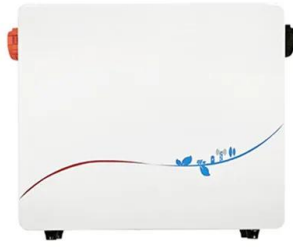

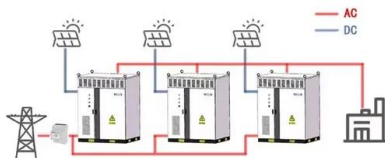


China Evergrande Facing Potential Wind-up Hearing on Monday
