### Can Enerflex & Exterran make an offer of securities?

In connection with the proposed Transaction, Enerflex and Exterran will file relevant materials with the Securities and Exchange Commission ("SEC").

Who is Exterran's legal advisor?

King & Spalding LLP and McCarthy Tétrault LLP are acting as Exterran's legal advisor. Enerflex Ltd. is a single source supplier of natural gas compression, oil and gas processing, refrigeration systems, and electric power generation equipment – plus related engineering and mechanical service expertise.

What does the transaction value paid for Exterran mean?

The transaction value paid for Exterran implies an EV/2022E Adjusted EBITDA of 3.6x and Price/2022E Cash Flow of 1.9x, including synergies, respectively. Upon closing of the Transaction, Enerflex and Exterran shareholders will respectively own approximately 72.5% and 27.5% of the total Enerflex common shares outstanding.
