Overview

On February 4, 2022, the President signed Proclamation 10339 “To Continue Facilitating Positive Adjustment to Competition from Imports.

Will bifacial solar panels be removed from safeguard tariffs?

A notable pivot in policy is the imminent removal of the bifacial module exclusion under Section 201. Bifacial solar panels, which are predominantly used in utility-scale projects, have enjoyed an exclusion from safeguard tariffs.

What are solar panel import tariffs?

Solar panel import tariffs are primarily intended to support the development of a new U.S.-based solar module manufacturing supply chain, which is financially backed by the Inflation Reduction Act. This act introduces a series of tax credits designed to bolster domestic manufacturers. For solar modules, the credits are as follows:.

Did Biden impose a tariff on bifacial solar modules?

The Biden administration later extended this tariff. Initially, the Section 201 tariff excluded bifacial solar modules, as no significant U.S. production existed.

However, as the U.S. module manufacturing base began to scale, the Biden administration recently reinstated a 15% tariff on bifacial modules.

Will Biden increase US import tariffs on Chinese solar panels?

Last week, President Biden announced plans to increase U.S import tariffs on Chinese solar cells and panels from 25% to 50% among a host of other products, on the grounds of unfair Chinese business practices.

Why is the global solar PV product trade important?

The global solar PV product trade plays an important role in facilitating PV product production and utilization and in mitigating climate change. Traded solar cells and modules in 2017 could generate 2325.25 TWh of electricity over their 30-year lifetimes.

How will US Customs and Border Protection (CBP) monitor solar products?

US Customs and Border Protection (CBP) will rigorously monitor compliance, necessitating detailed certifications from importers. Earlier in 2024, CBP began issuing questionnaires to solar companies requesting extensive disclosures about the source of modules, panels, and other products.

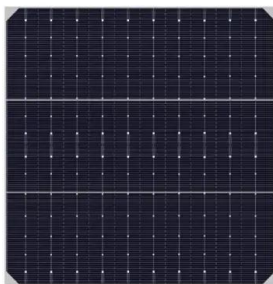

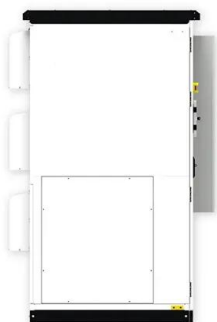
