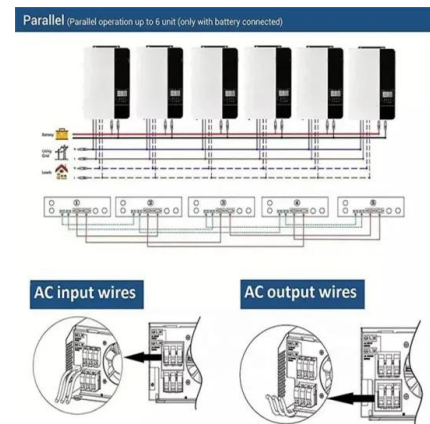

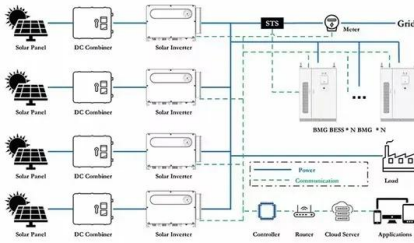

ACEN spending P26 B for integrated solar project

Giga Ace 8 said the plant's output will primarily be generated from solar power during daylight hours, with any excess solar generation stored in the BESS for use in the event of an energy deficit. "As solar generation diminishes, the battery will start to discharge into the grid until it is fully depleted," it noted.
