You won't have solar panels on your property the day after signing a contract. The time it takes before you're up and running with solar power largely depends on five factors: Your solar installation company. Local permitting and inspection processes. Size and type of solar panel system. Property characteristics.

After the contract is signed, communication between the new solar client and the solar company is vital to keeping all parties informed as the project moves through the construction stages. Often, a solar company may call, email, or utilize a texting application to send updates as the project moves through various milestones.

How long does it take to approve a solar panel system?

Similar to the approval process, the amount of time it will take for a utility company to approve a solar panel system interconnection will vary by utility. A study from the National Renewable Energy Laboratory (NREL) found that it typically takes one to two weeks after the installation dates to officially receive permission to operate (PTO).

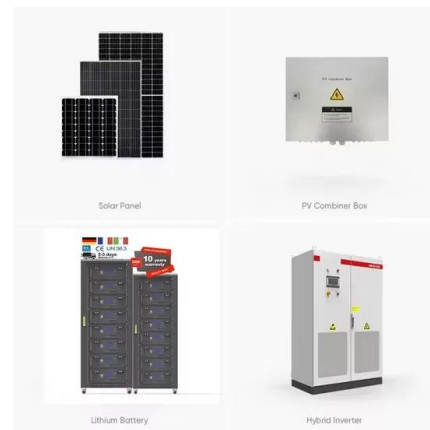
