In 2018, the US announced a protective tariff to all foreign PV products at 30% and reduced it by 5% each year. The EU took a CV investigation on China in 2012 and announced a CV duty of 11.80% in 2013. After that, Chinese companies are permitted to sell up to 7 GW PV products to the EU each year, and the price is no less than 0.56 Euro/W.

Asia-Pacific is one of the fastest-growing regions for the photovoltaic market, owing to the increasing energy demand and the shift towards renewable energy sources in countries like China, India, and Japan.

This 11th edition of the “Snapshot of Global PV Markets” aims at providing preliminary information on how the PV market developed in 2022. The 28th edition of the PVPS complete “Trends in Photovoltaic Applications” report will be published in Q4 2023. How much of China's PV exports deflect to new markets?

The results show that about 20 billion dollars of PV products, account for 22.66% of China's overall PV export, deflected to new markets from 2012 to 2016. Both local and destination spillovers are conducive for Chinese PV exports to deflect to countries without extra tariffs.

Does local and destination influence Chinese PV firms' market reorientation?

This paper manifests the PV trade deflection first and then investigates the role of both local and destination in the process of Chinese PV firms' market reorientation. The results show that about 20 billion dollars of PV products, account for 22.66% of China's overall PV export, deflected to new markets from 2012 to 2016.

Why are China's PV occupations different in different PV markets?

The discrepancy of China's occupations in different PV markets should be attributed to the impact of the trade sanctions. This paper estimates the trade deflection by comparing China's PV occupation in the ROW's market with the global market.

Does trade protection affect global PV trade patterns?

The global PV trade patterns Empirical studies predict that a shock that hits anywhere would be transmitted throughout the trade network ( Prusa, 1997 ). Accordingly, the impact of trade protection on Chinese PV export will inevitably transmit to global PV trade patterns.

How many dumping and import taxes are imposed on solar PV?

Since 2011, the number of antidumping, countervailing and import duties levied against parts of the solar PV supply chain has increased from just 1 import tax to 16 duties and import taxes, with 8 additional policies under consideration. Altogether, these measures cover 15% of global demand

outside of China.

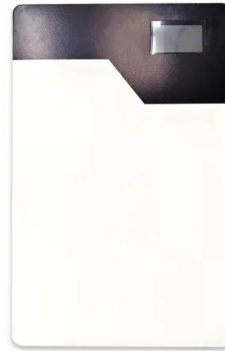
