Before we get into which states are making it harder to utilize solar power, we'll list the programs necessary for solar viability. Generally speaking, there are two kinds of incentives.

While many states possess solar programs and energy conservation initiatives, others are still behind. States like Georgia, Oklahoma, Kansas, and Nebraska include only the federally mandated bare minimum.

Buying a solar energy system makes you eligible for the Solar Investment Tax Credit, or ITC. In December 2020, Congress passed an extension of the ITC, which provides a 26% tax credit for systems installed in 2020-2022, and 22% for systems installed in 2023. Are solar panels a viable option?

However, some states still make installing solar panels functionally impossible by creating laws with “reasonable restrictions,” such as increased taxing, energy caps, or even billing solar panel users. Can you get a tax credit if you buy solar panels?

"The federal government does not have any programs that install solar panels on the homes of Americans for free," Jones-Albertus wrote. "A 30% tax credit is available to those who purchase a solar energy system."

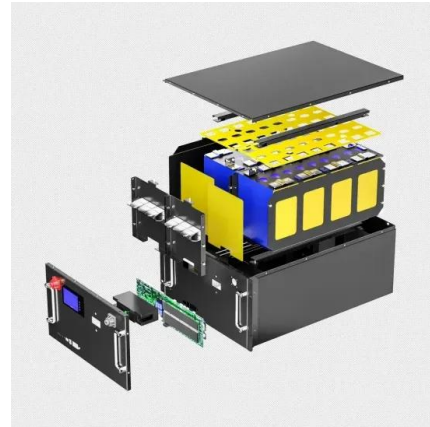
