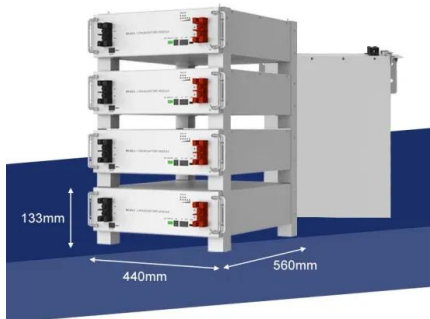

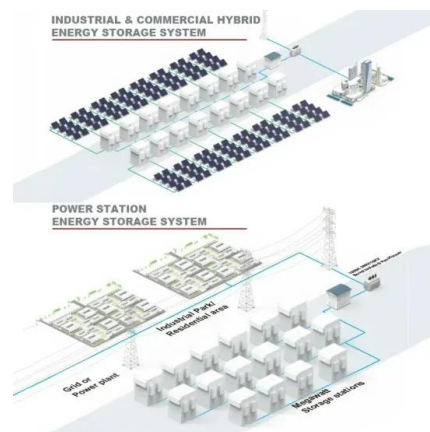

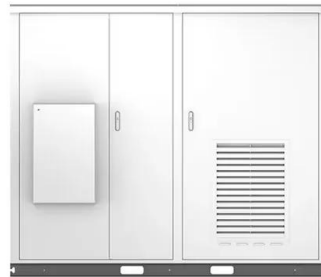
French renewable energy producer, Qair, has signed four PPAs with the Central Electricity

Envolt launches pioneering MUR 2.0 billion green bond ...

PV farms

EnVolt started producing electricity using solar energy some five years back, convinced that any surface exposed to the sun can potentially be converted into a power plant. It built its first plant on the rooftop of Phoenix Mall and from

there, it went on to power the other malls belonging to the group, ENL head quarters and hotel buildings.
