Is Sapura Energy a good investment?

Sapura Energy is expected to record a one-off gain of USD1.8m from its disposal of three rigs. We are generally positive on this, as the monetisation of non-core assets as proceeds will be used to fund working capital.

How did Sapura Energy Berhad restructure its debts in 2022?

On 10 March 2022, The High Court of Malaysia granted Sapura Energy Berhad (“Sapura Energy” or “the Group”) and 22 subsidiaries (collectively, the “Applicants”) two orders under Section 366 and Section 368 of the companies act to help restructure its debts and settle outstanding payments. 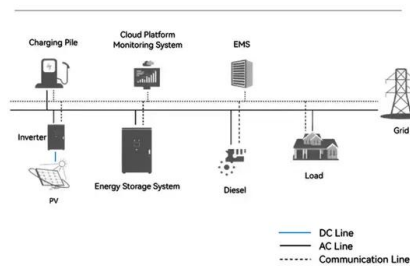
