Seeing a void in the tangible digital storage market, Vinpower, Inc. (dba Vinpower Digital), assumed the role by acquiring the rights to Moser Baer and introducing a new line of digital storage products under the Moser Baer brand.

Who is Moser Baer India?

Moser Baer India was founded in New Delhi in 1983 as a Time Recorder unit in technical collaboration with Maruzen Corporation (ja), Japan and Moser Baer Sumiswald (de), Switzerland. In 1988, it moved into the data storage industry, manufacturing 5.25-inch floppy diskettes. 1993, it started manufacturing 3.5-inch floppy diskettes (MFD).

What happened to Moser Baer?

A forensic audit of the company's finances found several irregularities in Moser Baer's accounts on 26 September 2018. The Central Bank of India declared Moser Baer's accounts as fraudulent on 20 April 2019. The Central

Bank of India filed a first information report against Moser Baer on 16 August 2019.

What happened to Phison Electronics & Moser Baer & Sahasra electronics?

In 2016, NAND flash device controller supplier Phison Electronics is partnering with Moser Baer and Sahasra Electronics, India's two largest electronics manufacturers, to expand its business in India, according to Phison chairman Khein Seng Pua. The company was ordered liquidated due to its bankruptcy on 20 September 2018.
