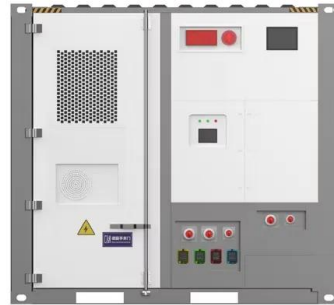

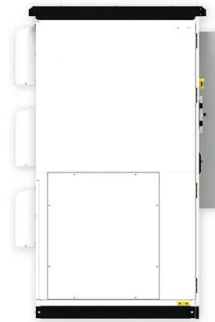

Smith v. Fonterra Co-Operative Group Limited

Michael John Smith (Ngāpuhi, Ngāti Kahu), climate change spokesperson for the Iwi Chairs' Forum, a Māori development platform, filed a case against seven high-emitting New Zealand companies in the agriculture and energy sectors, including the dairy farming conglomerate Fonterra, oil refinery NZ Refining Company, and petrol seller Z Energy.



One of NZ's most contentious climate cases is moving forward.

By allowing a case against local greenhouse gas emitters to go ahead, the Supreme Court of New Zealand has opened the door to a new front in climate law - one that takes tikanga Māori into
