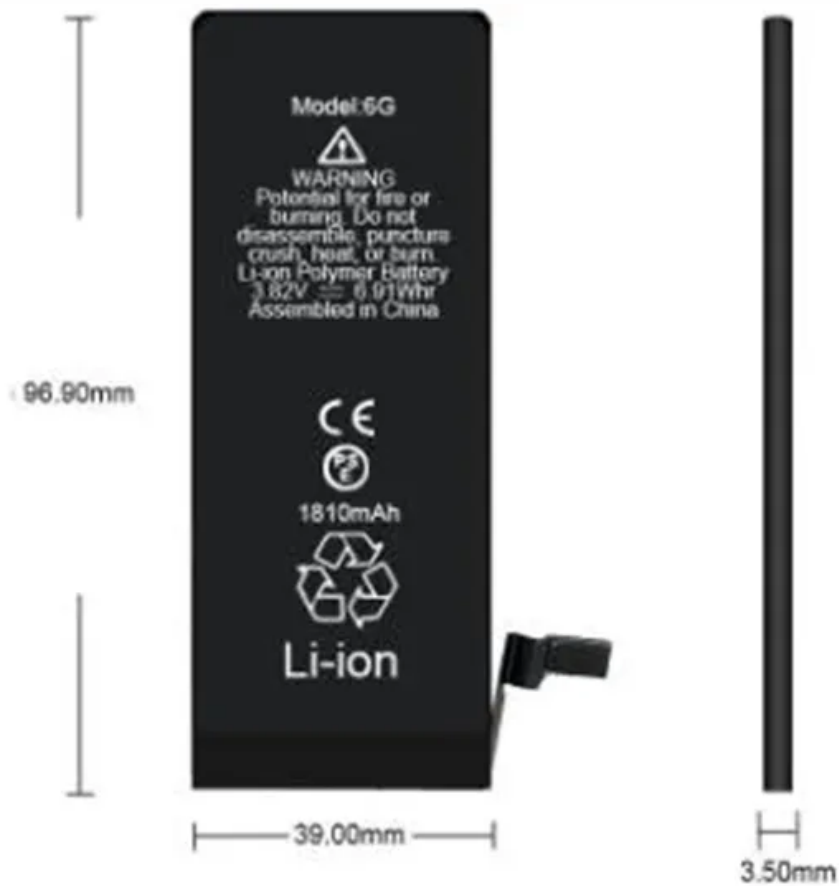

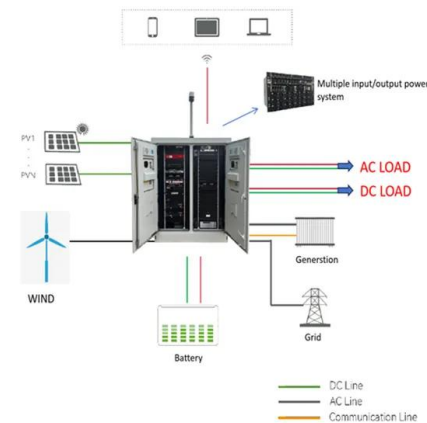


New solar project up and running in Lowndes County

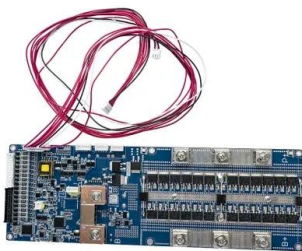
