Is Orsted a good company?

This has diversified its operations by renewable technology and geography, which supports the rating. Orsted also has a portfolio of combined heat and power plants with a heat capacity of 3.4GWe and power capacity of 2.5GW (based on biomass, coal and gas) that reported substantially higher EBITDA in 9M22 due to high power prices.

Is Orsted a leader in offshore wind?

Leading Offshore Wind Market Position: Orsted is the global leader within offshore wind with an installed capacity of 8.9GW at end-September 2022, predominantly in the UK, Germany, Denmark and the Netherlands.

What happened to Orsted a/s shares?

Orsted A/S shares touched the highest since August last year — when the Danish wind giant warned of a \$2.3 billion hit to its US portfolio — highlighting how the company is recovering from the crisis.

Is Norway's Equinor buying Orsted?

Norways Equinor has bought an almost 10pc stake in Danish wind-energy group Orsted, in what is a major move for the two companies. European stocks made a slight recovery, reversing earlier losses, as a series of trade announcements improved market sentiment. Signs that the European Central Bank is gearing up for interest rate cut.

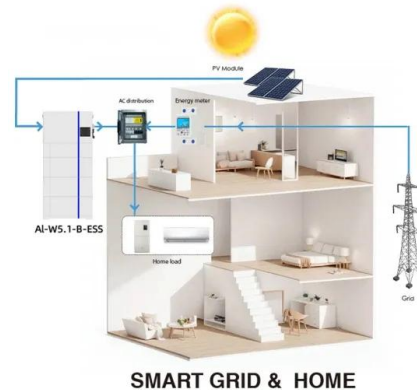

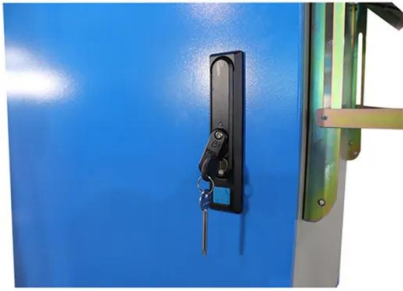
