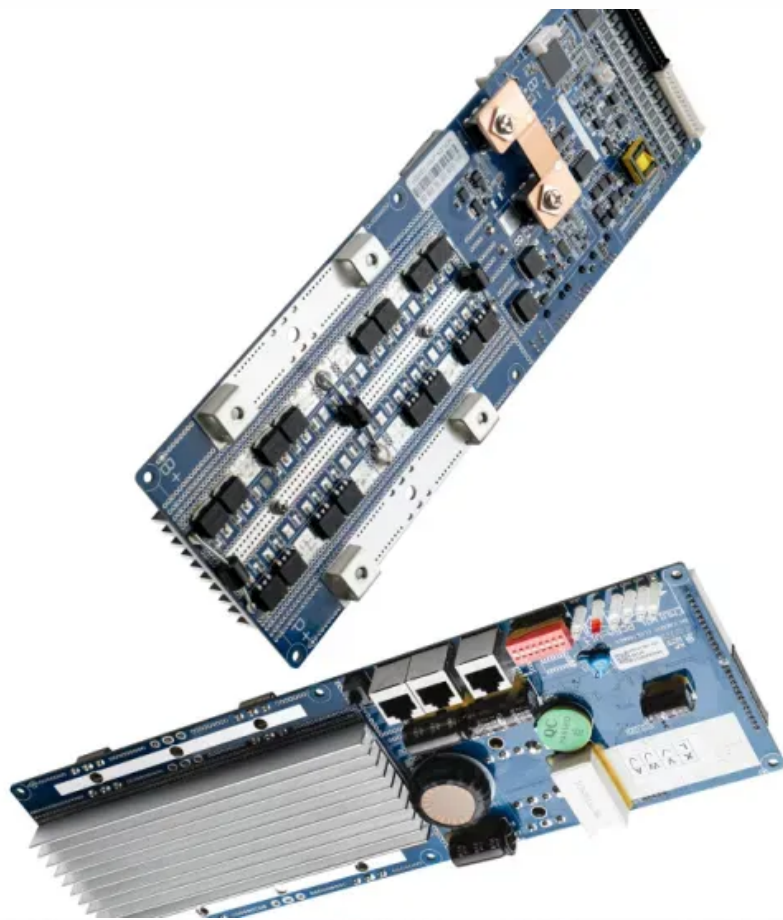

Strength. 1. Strong portfolio of power purchase agreements with large corporates in many countries: During 2021, in offshore wind energy Orsted A/S was able to expand its CPPA offshore wind portfolio with five agreements, further reducing the company's risk exposure to merchant prices and bringing the total signed CPPA volume within offshore up to 1,787 MW.

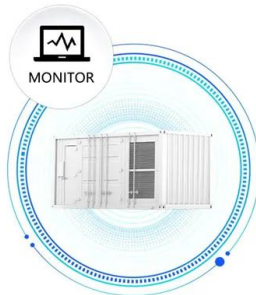

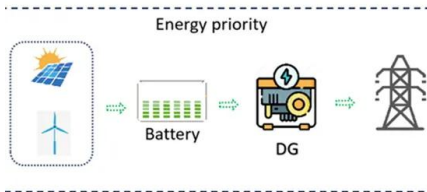
