Can a provider sell a photovoltaic system to a customer?

WHEREAS, Provider has offered, at his sole cost and expense, to install, maintain, own, replace, repair, and operate a photovoltaic system at one or more of the Property (ies) and to sell Solar Services (as hereafter defined) produced by the solar photovoltaic system to Customer as provided in and subject to the provisions of this Agreement.

What are the requirements for a photovoltaic module?

Proposed photovoltaic modules must be (i) Monocrystalline or Polycrystalline, (ii) eligible under the (State) Solar Initiative (“CSI”) Program; (iii) in compliance with IEEE standards, including, without limitation, IEEE 1262; (iv) UL listed; and (v) in compliance with the current National Electrical Code.

Do PV modules use hazardous materials?

If PV modules using hazardous materials are to be provided by the Developer, then the environmental impact of the hazardous material usage must be

discussed, including any special maintenance requirements and proper disposal/recycling of the modules at the end of their useful life.

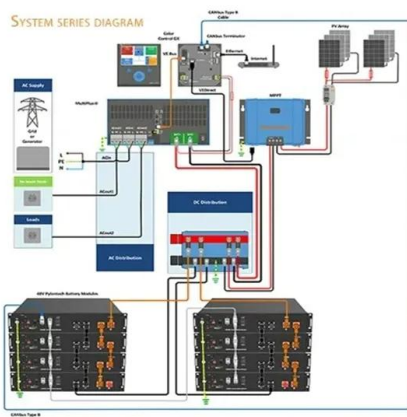
