Do I need a solar disclosure document?

to a Solar Disclosure Document from your solar provider. By law, a solar provider must provide you with a completed Solar Energy System Disclosure Document created by the Contractors State License Board (CSLB). This one-page document shows you the total costs for the solar energy system.

How do I request a solar panel removal & reinstallation?

Before we can proceed with your R&R, you'll need to confirm that your roof type is eligible for solar panel installation. Submit your R&R request to start the removal and/or reinstallation process from the Tesla app ('App' > 'Energy Site' > 'Support' > 'Get Help' > 'Other' > 'Removal & Reinstallation').

How do I dispose of solar panels?

Homeowners with solar panels on their houses should contact their state/local recycling agencies for more information on disposal/recycling. Federal solid and hazardous waste regulations (i.e., the RCRA requirements) apply to solar panels when they are discarded.

Are solar panels regulated at end of life?

If you are disposing of solar panels that are hazardous waste, then regulations under the Resource Conservation and Recovery Act (RCRA) must be followed to make sure the panels are safely recycled or disposed of. What happens if a solar panel is discarded?

Federal solid and hazardous waste regulations (i.e., the RCRA requirements) apply to solar panels when they are discarded. When a solar panel reaches the end of its usable life or is otherwise discarded, it becomes solid waste. Solid waste is regulated federally under RCRA Subtitle D and through state

and local government programs.

Are solar panels a hazardous waste under RCRA?

If these metals are present in high enough quantities in the solar panels, solar panel waste could be a hazardous waste under RCRA. Some solar panels are considered hazardous waste, and some are not, even within the same model and manufacturer.
