Supplier assessment system has been improved through tendering and procurement. This is to create a fair and just competition environment for suppliers.

What happened to Xinyi Solar (Haikou) limited?

On 24 February 2023, a wholly owned subsidiary of the Company completed the disposal (the "Disposal") of all issued shares of Xinyi Solar (Haikou)

Limited and its subsidiary (“Xinyi Haikou Group”) to Xinyi Energy for cash consideration of approximately HK\$144.5 million pursuant to a sale and purchase agreement dated 11 April 2022.

Will Xinyi energy renew the solar farm operation and management agreement?

As disclosed in the Company’s announcement dated 31 December 2021, the Company entered into a memorandum (the “Renewal Memorandum”) dated 31 December 2021 with Xinyi Energy to renew the solar farm operation and management agreement (the “O&M Agreement”) for the three years ending on 31 December 2024.
