Can long duration electricity storage save energy?

Long Duration Electricity Storage would reduce costs to consumers through lowering their energy bills, by avoided electricity grid reinforcement and avoided peak generational plant build. LCP's modelling estimates savings for the energy system (and ultimately the energy consumer) of up to £24 billion by 2050.

What is a battery energy storage system?

Battery Energy Storage Systems (BESS) and associated works are a key component of a low carbon energy system. Their batteries can store the energy being generated across the UK's energy network by renewables, such as solar and wind farms, when demand is low so excess electricity isn't wasted.
