# Residential solar power generation declaration



## Overview

---

What is the Federal residential solar energy credit?

The federal residential solar energy credit is a tax credit that can be claimed on federal income taxes for a percentage of the cost of a solar PV system paid for by the taxpayer. (Other types of renewable energy are also eligible for similar credits but are beyond the scope of this guidance.)

How do I claim a residential energy credit?

File Form 5695, Residential Energy Credits with your tax return to claim the credit. You must claim the credit for the tax year when the property is installed, not merely purchased. For additional instructions on how to claim the credit for residential clean energy follow our step-by-step guide.

Are solar PV systems eligible for a tax credit?

Solar PV systems installed in 2020 and 2021 are eligible for a 26% tax credit. In August 2022, Congress passed an extension of the ITC, raising it to 30% for the installation of which was between 2022-2032. (Systems installed on or before December 31, 2019 were also eligible for a 30% tax credit.)

How do I get a solar tax credit?

Fill out your Form 1040 as you normally would. Stop when you reach line 20, and move to Schedule 3, where you can fill in other payments and additional credits, like the solar tax credit. To figure out your tax credit value, you'll use Form 5695. Today, we're helping "Example Exampleson," who hails from Minnesota, dontcha know.

When does the solar tax credit expire?

It will decrease to 26% for systems installed in 2033 and to 22% for systems installed in 2034. The tax credit expires starting in 2035 unless Congress renews it. There is no maximum amount that can be claimed. Am I eligible to claim the federal solar tax credit?

You might be eligible for this tax credit if you meet the following criteria:.

Can I claim a tax credit for an off-site solar project?

Notes: the IRS issued a statement (see link above) allowing a particular taxpayer to claim a tax credit for purchasing an interest in an off-site community solar project. However, this document, known as a private letter ruling or PLR, may not be relied on as precedent by other taxpayers.

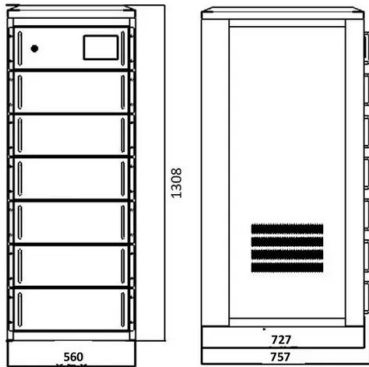
