Energos Infrastructure, an international marine LNG infrastructure company, majority-controlled by Apollo-managed funds and minority shareholder New Fortress Energy Inc., has completed the acquisition of two state-of-the-art FSRUs from affiliates of Dynagas.

Where will The Energos force FSRU operate?

Having commenced a long-term charter contract with the German Federal Ministry of Economic Affairs and Climate Change in 2023, the Energos Force FSRU will operate in the port of Stade under the direction of Deutsche Energy Terminals.

How many LNG infrastructure vessels does Energos infrastructure own?

With these two high-specification LNG regasification vessels added to its platform, the venture now owns and operates 13 LNG infrastructure vessels consisting of nine FSRUs, two floating storage units and two LNG carriers. Energos Infrastructure has completed the acquisition of two FSRUs from affiliates of Dynagas.

What makes Energos the largest owner of LNG vessels in Europe?

The addition of the Energos Force and Energos Power in Europe makes Energos the largest owner and operator of LNG marine infrastructure vessels by wholly-owned FSRU capacity operating within the continent.

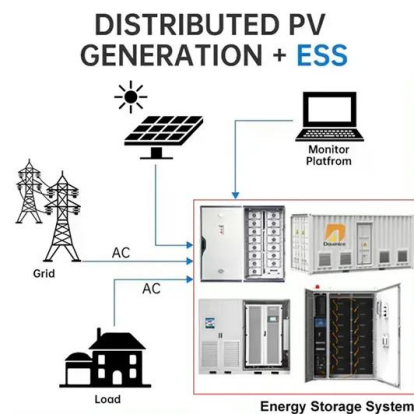

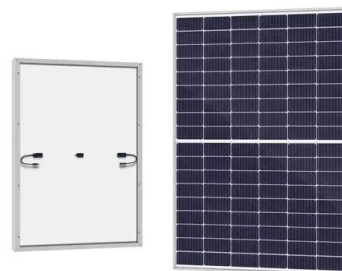

## Energos Infrastructure buys two Dynagas FSRUs

The two 174,000-m<sup>3</sup> closed-loop FSRUs will be renamed Energos Force (ex-Transgas Force) and Energos Power (ex-Transgas Power). Each 294 m x 47 m FSRU combines all the functions of a traditional LNG carrier and land-based receiving station with LNG transport, receiving, storage and regasification functions.
