What is a solar power purchase agreement (PPA)?

A solar power purchase agreement (PPA) is a financial contract in which a third-party developer owns, operates, and maintains the photovoltaic system, and a customer agrees to purchase the system's electric output from the solar services provider for an agreed-upon price and for a predetermined period.

Who determines the final content of a solar PV solicitation?

Agency contract officers, attorneys, and engineers are responsible for determining the final content of any solicitation. Updated to the regulations, codes, and standards applicable to solar PV are changing frequently; it is the responsibility of agency managers to determine which guidelines (and which versions) apply. What is a solar RFP?

But first a few key definitions: A Request for Proposal (RFP) is a formal bid document to ask vendors to provide proposals for desired projects, as required by many public agencies (federal, state, local). A solar RFP outlines the photovoltaic (PV) product or service requirements, the contract terms, and bidding process.

What is a solar contract?

Solar Contracts are fine-tuned for small and medium-sized, grid-connected solar PV projects. Standardised contracts include: Power Purchase Agreement, Implementation Agreement, O&M Agreement, Supply Agreement, Installation Agreement and Finance Facility Term Sheet. These are complemented by the Implementation Guidelines.

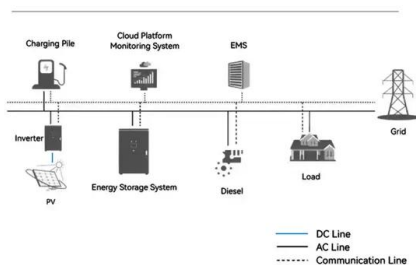
