Energy in Sweden is characterized by relatively high per capita production and consumption, and

a reliance on imports for fossil fuel supplies. With 98% of electricity generation coming from renewables and nuclear in 2023, the electric grid is nearing zero emissions. [1]

Executive summary - Sweden 2024 - Analysis

Sweden's legally binding 2045 net zero emissions target together with energy sector targets guide its energy policy. Net zero equates



to an 85% cut in domestic greenhouse gas (GHG) emissions from 1990 levels (38% below 1990 levels in 2023), after allowing for expected absorptions.
