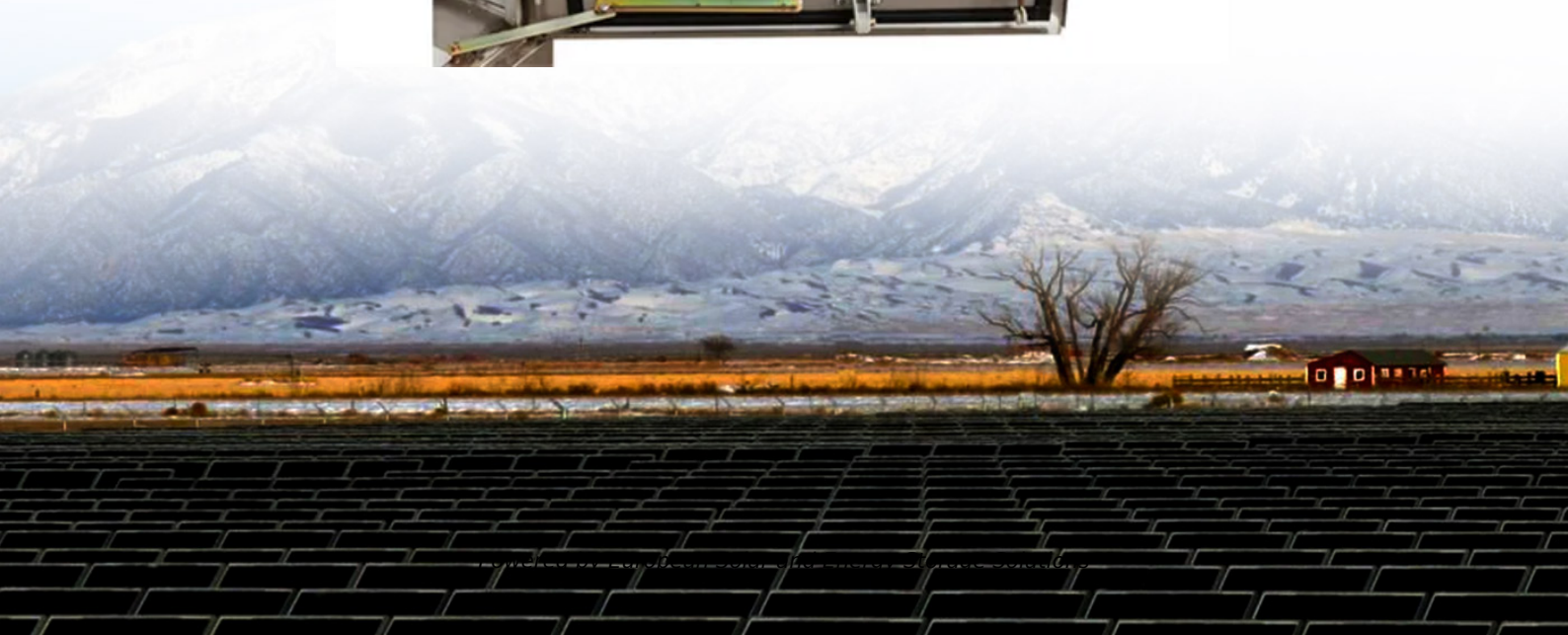

Overview

What is a solar RFP?

But first a few key definitions: A Request for Proposal (RFP) is a formal bid document to ask vendors to provide proposals for desired projects, as required by many public agencies (federal, state, local). A solar RFP outlines the photovoltaic (PV) product or service requirements, the contract terms, and bidding process.

Who determines the final content of a solar PV solicitation?

Agency contract officers, attorneys, and engineers are responsible for determining the final content of any solicitation. Updated to the regulations, codes, and standards applicable to solar PV are changing frequently; it is the responsibility of agency managers to determine which guidelines (and which versions) apply. What is a solar power purchase agreement (PPA)?

A solar power purchase agreement (PPA) is a financial contract in which a third-party developer owns, operates, and maintains the photovoltaic system, and a customer agrees to purchase the system's electric output from the solar services provider for an agreed-upon price and for a predetermined period.

What is a US Virgin Islands solar PPA & RFP?

US Virgin Islands solar PPA and RFP (in English). PPA and RFP documents for a project whereby the Virgin Islands Water and Power Authority is seeking a maximum of 10 megawatts (MW) of electrical capacity, allocating approximately 5 MW to each of its two generation facilities serving the districts of St. Thomas-St. John and St. Croix.

What happens if a solar contractor is awarded a contract?

Upon an award, the solar contractor is bound to execute the contract and begin performance. If another contractor that supplied a proposal thinks that

it had the best value proposal, the contractor can question the government's evaluation process.

Which country has issued a new PPA for rooftop solar projects?

The Vietnamese Government has issued a new model PPA for rooftop solar projects under Circular No. 05/2019 TT-BCT, dated 11 March 2019. RenovAR, Argentina has been holding public auctions to buy RE under a program called "RenovAR". The program applies for wind energy, solar energy, biomass and small hydroelectric plants and biogas.
