How much solar power does Spain need?

The Spanish National Energy and Climate Plan (NECP) has set a target of more than 39 gigawatts of solar PV power installed in the country by 2030. In 2020, the solar PV capacity installed in Spain amounted to 11.5 gigawatts, surpassing the target set for that year by approximately 2.5 gigawatts.

In recent years, Spain has experienced a significant boom in the solar energy sector, becoming a benchmark in Europe. This growth has led to a growing interest on the part of individuals and companies in the installation of photovoltaic projects to take advantage of the potential of solar energy.

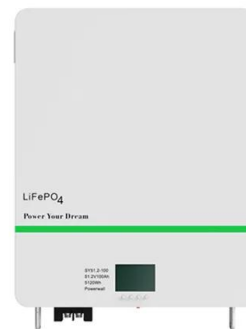

In September 2002, Spain was the first European country to introduce a "feed-in tariff" funding system for solar thermal power. This funding system granted a premium on top of the electricity pool price of 12 EUR cents for each kWh output of a solar thermal plant between 100 kW and 50 MW of capacity, which could be changed every four years.

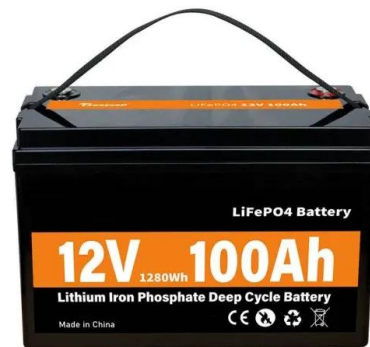
