# Solar photovoltaic panels subsidies



## Overview

---

The main incentive programs that allow homeowners to benefit from solar energy include:

- Tax credits:** Homeowners can get federal tax credits when they buy a photovoltaic system. These credits can account for up to 30 percent of the total cost of installing a PV system.

The solar panel tax credit allows filers to take a tax credit equal to up to 30% of eligible costs. There is no income limit to qualify, and you can claim the credit each year you're eligible for it.

Are solar panels eligible for the federal solar tax credit?

Free, No-commitment Estimates To be eligible for the federal solar tax credit, you need to install a solar-powered energy system that provides electricity to a U.S. residence. Solar panels, solar water heaters and energy storage devices are all included in the credit.

Are solar PV systems eligible for a tax credit?

Solar PV systems installed in 2020 and 2021 are eligible for a 26% tax credit. In August 2022, Congress passed an extension of the ITC, raising it to 30% for the installation of which was between 2022-2032. (Systems installed on or before December 31, 2019 were also eligible for a 30% tax credit.)

Are solar panels tax deductible?

Under most circumstances, subsidies provided by your utility to you to install a solar PV system are excluded from income taxes through an exemption in

federal law. When this is the case, the utility rebate for installing solar is subtracted from your system costs before you calculate your tax credit.

Who will receive a \$7 billion solar grant?

Washington – Today, April 22, as the Biden-Harris Administration celebrates Earth Day, the U.S. Environmental Protection Agency announced 60 selectees that will receive \$7 billion in grant awards through the Solar for All grant competition to deliver residential solar projects to over 900,000 households nationwide.
