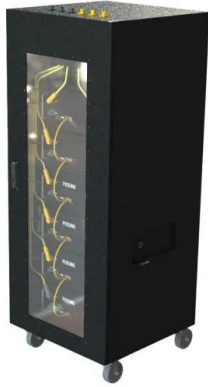

Looking at the latest available offers in May 2024, we found that:

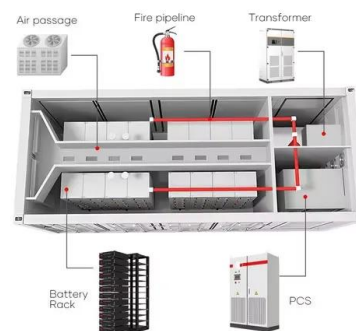
