Can a company run a business in the Cayman Islands?

It is not permitted to conduct local business in the Cayman Islands, unless it holds a licence to do so. An exempted company is incorporated by the subscription (signature) of the initial shareholder (s) to the memorandum of association.

What is a Cayman Islands exempted company?

It is not intended to be comprehensive and is not a substitute for professional advice in the context of a particular set of circumstances. A Cayman Islands exempted company is a type of company that is commonly used to undertake business activities exterior to the Cayman Islands.

What is the government fee in the Cayman Islands?

In the Cayman Islands, the annual government fee paid by an exempted company is based upon the authorised share capital rather than the issued share capital. The lowest government fee band is for authorised share capital up to US\$50,000 (or currency equivalent).

Does the Cayman Islands impose tax?

Cayman Islands law does not impose direct tax of any kind. Stamp duty may be payable on original documents executed or otherwise brought into the Cayman Islands certain circumstances but the charges are generally nominal in nature.

What is a certificate of incorporation in Cayman Islands?

Once the memorandum and articles of association, declaration and incorporation fee are submitted to RoC, a certificate of incorporation is issued which serves as evidence that the exempted company has been incorporated and registered in accordance with the Companies Act (As Revised) of the Cayman Islands (the " Act ").

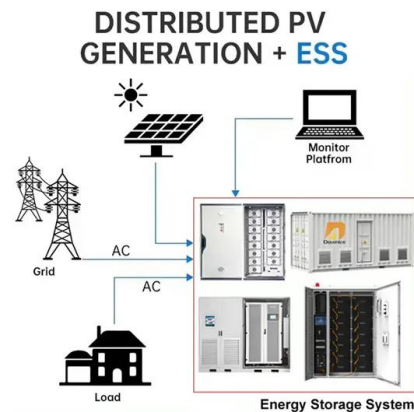
