As the "front-runner" of scientific and technological innovation, STAR Market companies implemented the innovation-driven development strategy in the first half of the year, continuously increased investment in R&D, orderly promoted investment projects financed by raised funds, and accelerated development with the help of the innovation system.

Taking the most recent fiscal year (2018) as an example, the average R&D investment of the sci-tech innovation enterprises whose applications have been accepted accounted for 11% of the total operating revenue, with the highest proportion at 56%, and their R&D personnel took up 33% of the total number of the employees.
