The PV system installation generally takes only a few days, but it can take weeks to months get the necessary permits and inspections, and it largely depends on the local regulations in your area. The National Renewable Energy Laboratory's SolarTRACE tool can give you a general idea of how long it may take to complete the permitting .

Before you install solar panels on your roof, find answers to these 8 questions to make sure solar will save you money and energy.

The Residential Clean Energy Credit, often called the federal solar tax credit, is an incentive you can earn when installing solar panels or other clean energy equipment on your property. The tax credit equals 30% of installation costs and can reduce what you owe in federal income taxes by thousands of dollars.

Generally, you can claim a tax credit on the expenses related to the new solar PV system that already came installed on the house for the year in which you moved into the house (assuming the builder did not claim the tax credit)—in other words, you may claim the credit in 2021. Are solar panels eligible for the federal solar tax credit?

Free, No-commitment Estimates To be eligible for the federal solar tax credit, you need to install a solar-powered energy system that provides electricity to a U.S. residence. Solar panels, solar water heaters and energy storage devices are all included in the credit.

Can I claim a tax credit if I install a solar PV system?

Yes, but if the residence where you install a solar PV system serves multiple purposes (e.g., you have a home office or your business is located in the same building), claiming the tax credit can be more complicated.

Can you install solar panels on a roof?
